Subject:- Grant of recognition to the school from class Ist to VIII (without aid) w.e.f. academic session 1987-88.

Sir,

With reference to your application on the subject noted above, I am directed to grant recognition to your school from class Ist to VIII (without aid) w.e.f. 1987-88 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973 framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of West Patel Nagar area.
3. That the school shall appoint full time qualified and eligible staff for all the classes of the school as per the present norms of the department and unqualified staff shall be replaced by qualified if any.
4. That the school shall equip the science Lab. as per the norms of the department and suitable facilities for practical work shall be provided to the students. More materials worth Rs. 5000/- shall be purchased in May, 1988 and a list be furnished to E.O. for verification.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading room may also be provided immediately. More books worth Rs. 5000/- (Rupees five thousand) may be purchased by the May, 1988 and the list of books be furnished to E.O. for verification.
6. That adequate sports materials worth Rs. 3000/- shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of Delhi School Education Act and Rules, 1973 and payment shall be made as per sec. 10(1) of DSEA, 1973 and to all employees.

8. That the enrolment in each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of the existing sections should not exceed the number of the class room of proper size in the school.
9. That the school/society shall obtain land from the DDA for the unaffiliated school and shall shift its classes to the new site with the prior permission of D.E.
10. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
11. That until the conditions under Rule 50 and 51 would be fulfilled before 15th May, 1988 and with warning that such false advertisement if given again the recognition of the school would be withdrawn without any show cause notice. Provisions of rules 6, 7 and 9 be strictly observed.
12. That the arrangement for good drinking water shall be made available to all the students as well as teachers, and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the Local Body within a month.
13. That the service contract between the management and the employees shall be executed immediately.
14. That the management of the school shall create a Reserve fund of Rs. 5000/- (Rupees five thousand) only in a joint account in the name of the Director of Education and the Manager of the school in any scheduled bank within a month.
15. That the violation of any instructions/orders/conditions/ rules and regulations of the department shall lead to the withdrawal of recognition of the school and class IX shall not be opened without the prior approval of the Director of Education, Delhi.

16. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six month.
